

## PROGRAM EFFECTIVE JANUARY 1, 2020

ClearPath Mutual has partnered with the Kentucky Chamber of Commerce to offer all of its members and its participating affiliate chambers a premium reduction on their policies **effective 1/1/2020, and thereafter.**

### MEMBER QUALIFICATIONS

Here are the qualifications that must be met to receive benefits from this program:

- **Must be a member in good standing with the chamber on the effective date of the policy, or within the first 30 days of coverage.**
- **Annual Premium must be at least \$600 (before the association discount).**
- **Minimum of 2 years in business.**
- **Experience mod of 1.30, or less.**
- **Cooperation with Loss Prevention Services.**
- **All other existing Underwriting Guidelines prevail.**

Membership must be confirmed with each chamber no later than **30 days** into the policy.



### ASSOCIATION DISCOUNT

Members of any participating chamber will receive a **total of 10%** discount off their estimated annual premium.

It is the responsibility of the agent and/or insured to notify us that the policyholder is a member of any chamber participating in the program.

### Q&A

#### Are current ClearPath Mutual policyholders eligible?

Yes! Existing ClearPath Mutual policyholders are eligible for the association discount **at their renewal, after 1/1/2020.**

#### How will I know the premium discount has been applied?

You will see the discount listed in the premium calculation under "Association Discount".

#### When submitting an application for a chamber member, how do I notify ClearPath Mutual?

##### Emailed submissions:

Let us know in the email that the insured is a member, along with which chamber(s) they are a member of.

##### Portal submissions:

In the Underwriting Questions section of the application, please select which chamber the insured is a member of.
